### **Customs and Border Protection (CBP):**

Compartment training will be provided by CBP personnel. Agents from the southwest border will provide photographs and video of the most current concealment methods being utilized by criminal organizations.

**Trooper Ryan Fletcher** is currently employed as a full-time criminal interdiction trooper with the Tennessee Highway Patrol and is the task force commander of the Appalachia HIDTA DHE-IP task force. Ryan has been in law enforcement since 2011, with most of that time working in an interdiction capacity. Before beginning his career with the Tennessee Highway Patrol, Ryan helped start the first full-time interdiction team for the 8th Judicial Drug Task Force. Ryan joined the Tennessee Highway Patrol Interdiction Plus team as a full-time member in 2019. Ryan has continued his pursuit of advanced interdiction training and has since become an instructor for the Tennessee Highway Patrol's Interdiction Plus team. Ryan has received many awards, including the drug officer of the year, looking beyond the stop award, and the 2020 largest cocaine seizure by BLOC Gulf Coast HIDTA.

**Trooper Brad Harper-Captain KSP-Retired** is a 27-year veteran of law enforcement, starting in 1995 as a patrol deputy with the Warren County Sheriff's Office. In January of 2001, Captain Harper was hired by the Kentucky State Police (KSP) as a State Police Trooper. Captain Harper has been involved in hundreds of narcotics investigations to include criminal conspiracies in Kentucky and Tennessee. He has worked large narcotics cases that went from Kentucky to California and many states in between. He has been assigned to the Federal Bureau of Investigations (FBI), Alcohol Tobacco firearms and explosives (AFT) and the DEA for federal wire case. Captain Harper has received accommodations for drug investigations that were investigated, and large drug trafficking organization were dismantled.
