**COURSE DESCRIPTION:** Palestra Group International in coordination with LNC Security Consulting has developed a one-day “Ghost Gun” and 3D Printing Investigations Course designed to assist prosecutors and officers with target development and long-term investigations into the manufacture and trafficking of Personally Made Firearms or “ghost guns”. The course highlights the use of open-source intelligence, online retailer information, the utilization of undercover operators, and case development beyond the trafficker. The course also details the significant differences between Commercially Manufactured Firearms and Personally Made Firearms (Ghost Guns) and the implementation of current State and Federal guidelines. Covering actual in-depth case studies, this course gives attendees the tools to identify, initiate, develop and interdict PMF manufacturers within their own jurisdiction. This course is presented by former prosecutors, case officers and undercover operators that pioneered the New York City, State, and National model for identifying, investigating and interdicting ghost gun manufacturers and traffickers. Our instructors cover the steps in conducting in-depth long-term investigations; and includes hands-on access to current inert advanced DIY and 3D printed weapons systems, allowing officers to see and feel the weapons representing the current threat landscape.
